# **BEAULY DISTRICT FISHERY BOARD**

# Chairman's Report 2012-2013

## 1. Catches

### Salmon

In the 2012 season 1,394 fish were reported to the Board as being caught. 72% of the fish caught were reported returned, a slight drop on previous years' figures. Of the total reported, 117 (8.4%) were caught prior to 30 June. As in previous years, the Board's recommended Conservation Policy was circulated to all Proprietors. I would encourage all Proprietors to comply with this.

Returns were not received from one proprietor – Mr Kwint, River Glass. Previous five years catches are shown below.

Previous years: 2011 - 1,154 2010 - 1,714 2009 - 1,295 2008 - 1,186 2007 - 1,335

The statutory returns reported by Marine Scotland give a total of 1,357 salmon caught on the Beauly system, of which 1,030 (76% were returned).

The salmon catch figure for 2012 was around average for the last 10 years. In keeping with many rivers in Scotland, the season was characterised by a strong but short grilse run around late July which then fell away quickly. The spring saw unusually low water caused by the prolonged easterly airflow. Very little rainfall fell on the western hills at the top of the catchment and the release of water through the dams barely rose above compensation for much of the spring. Lower numbers of fish were seen later in the season. The upper beats started very slowly but picked up good numbers of fish in later summer, early autumn.

### **Sea Trout**

Total sea trout catch reported to the Board was 351, slightly down on 2011. However the Marine Scotland figures, taken from statutory returns, indicate a total catch of only 325, with 307 being released, a release rate of 95%.

These figures are provided by SSE. On both the Kilmorack and Aigs dams there were a couple of weeks where the counter did not report the number of fish through the pass. The above figures are therefore almost certainly an underestimate. However they do indicate that numbers returning to the river in 2012 were significantly better than in 2011 and closer to longer term averages.

### 3. Licences

A licence was obtained for the control of piscivorous birds. This licence was organised by Keith Williams in conjunction with the Spey District Fishery Board and was for the period 18 January 2011 to 30 April 2011. The total licence was for 2 mergansers and one cormorant, all of which were shot.

A licence for has been received for 2 mergansers and 7 gooseanders in 2013. Those ghillies nominated as marksmen attended a briefing session in March 2013 to outline their obligations under the Wildlife & Countryside Act 1981 and the Wildlife and Natural Environment (Scotland) Act 2011.

In April 2012 the District Fishery had a licence to shoot two common seals and two grey seals under the Moray Firth Seal Management Plan. One common seal was shot within the river.

A licence for 2 common and 2 grey seals has been received for 2013.

### Baillifs

There are currently four baillifs warranted by the Board. A fifth warrant has also recently been issued.

Poaching incidents remain a concern on the Beauly, particularly above Kilmorack and Aigas dams. A successful prosecution resulted in 2012 following the arrest of a poacher on the Beauly.

## 5. DSFB Code of Practice

The Board has signed up to the Code of Practice for District Salmon Fishery Boards prepared by ASFB and will continue to monitor this to ensure the objectives are being met where applicable.

## 6. Ness & Beauly Fisheries Trust

The Board continues to work closely with the Ness and Beauly Fisheries Trust. Dr. Keith Williams will update the Board on current progress on habitat management and fish genetics at the Board meeting.
